All candidates, whose placement has been changed from that of DOJ placement should be released by 31st August 2012 with an advice to report to HOHR at the place of final posting, after availing admissible travel time. However the specific date of relieving and reporting will be mentioned in the individuals' orders issued by the HR department, where they were undergoing DOJ training. All such ETs will not be entitled for any travel allowance or dearness allowance for joining at new place of posting.

ETs, who were allowed to undergo DOJ at locations on their own request, are advised to report to HOHR of their final place of posting by 16th August, 2012.

ETs being posted in JVs and Subsidiaries on regularization will be on secondment basis and will be governed by the terms and conditions of employment as per company rules.

Necessary entries/changes in SAP are to be affected by concerned HR-EB Officer of the final place of posting on regularization. In case change of posting or movement to final posting from alternate DOJ location, HR Coordinator or EDC In charges of their DOJ training Project/station are requested to update their leave records in ET Handbook and send the same to the HR departments of candidate's new place of posting

HOHR of Projects/Stations where ETs are posted on regularization are requested to arrange for collecting the Personal Files of ETs from PMI. The contact person in this regard at PMI is Sh. R P Gupta, Dy. Manager (HR), 120-2416862, 9650992878. The person authorized to collect personal files must carry an authorization letter from HOHR along with list of Executives with Employee number.

All the above Engineers would be on probation for a period of one year as per the rules of the company. Other terms and conditions of appointment remain unchanged.
